Section I. Invitation to Bid

Local Access Road in Barangay Loguilo and Barangay Lagtang, Alubijid Misamis Oriental (STA.0+058.00 - STA.0+880.00)

1. The Local Government Unit of Alubijid, through the DILG (LGSF-AM) Program intends to apply the sum of **Seven Million Four Hundred Seven Thousand One Hundred Pesos (Php 7,407,100.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Local Access Road in Barangay Loguilo and Barangay Lagtang, Alubijid, Misamis Oriental (STA.0+058.00 - STA.0+880.00), 2018-59**. Bids received in excess of the ABC shall be automatically rejected at bid opening.

2. The Local Government Unit of Alubijid now invites bids for **Local Access Road in Barangay Loguilo and Barangay Lagtang, Alubijid, Misamis Oriental (STA.0+058.00 - STA.0+880.00)**. Completion of the Works is required 150-calendar days. Bidders should have completed, **within the last five (5) years** from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act 9184 (RA 9184), otherwise known as the "Government Procurement Reform Act."

Bidding is restricted to Filipino citizens/sole proprietorship, cooperatives, and partnerships or organizations with at least seventy five percent (75%) interest or outstanding capital stock belonging to citizens of the Philippines.

4. Interested bidders may obtain further information from the Local Government Unit of Alubijid and inspect the Bidding Documents at the address given below from 8:00 –5:00 o'clock in the afternoon.
5. A complete set of Bidding Documents may be acquired by interested bidders on October 10 – October 30, 2018, from the address below and upon payment of the non-refundable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of **Php10,000.00**.


It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The Local Government Unit of Alubijid will hold a **Pre-Bid Conference on October 18, 2018 at 2:00 o'clock in the afternoon at Conference Room 3rd Floor, Municipal Hall, Poblacion, Alubijid, Misamis Oriental**, which shall be open to prospective bidders.
7. Bids must be duly received by the BAC Secretariat at the address below on or before **12:00 noon of October 30, 2018**. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB Clause 18**.

Bid opening shall be on **October 30, 2018, 2:00 o'clock in the afternoon at Conference Room 3rd Floor Municipal Hall, Poblacion, Alubijid, Misamis Oriental**. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.

8. The Local Government Unit of Alubijid reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Section 41 of RA 9184 and its IRR, without thereby incurring any liability to the affected bidder or bidders.
